Evaluation Summary

WAS THE AGENDA FOR THIS MEETING ADEQUATE AND DID IT MEET YOUR EXPECTATIONS?

- The agenda was heavy with federal agency presentations. Although good information, I would have liked to have seen greater involvement from the tribes.
- Yes, the agenda was robust and contained a varied assortment of relevant topics.

WHAT COULD THE TPPC MEETING PLANNERS HAVE DONE TO MAKE THIS MEETING MORE USEFUL TO YOU?

- A more structured hot topics session or tribal caucus. This is dependent upon the participating tribes, however often discussions stray from being pesticide related.
- The TPPC meeting planners did a great job. The meeting would have been more useful if EPA had provided more discussion, insights, information, etc.
- I thought the planners did a great job. There were several areas covered on a variety of topics.

FOR FUTURE MEETINGS, PLEASE SUGGEST TOPICS / SPEAKERS WHO YOU FEEL COULD HELP IMPROVE THE AGENDA.

- Suggest inviting folks from industry (Syngenta, Bayer Crop Science, BASF, Dow, etc.) or large end
 use operators (Orkin, Terminix, etc.) They would likely have perspectives many tribes do not
 hear from, at least not in a non-regulatory role. There appears to be bias (unfortunately, slowly
 approaching activism) in the TPPC membership against industry and it would be nice to hear
 about their processes, projects or research which work towards addressing some of the
 concerns expressed with pesticides and the environment. Lastly, more topics intended to aid in
 a tribe's ability to grow capacity are needed.
- Someone from EPA who can speak on budgets and how they allocate money to Tribes.
- Treaty Rights/Sovereignty

HOW WILL THIS MEETING STRENGTHEN YOUR CAPABILITY TO BETTER IMPLEMENT YOUR PROGRAM?

- As with past meetings, hearing from other's tribes' successes and lessons learned is always
 helpful if relatable to a local challenge. These are of greater value to me than general
 awareness type presentations when it comes to day in day out operations. I do not know how
 valuable a discussion or presentation on PFAS may be for a tribe who faces challenges managing
 their work plan (if one of the 19 cooperative agreements) or has difficulties working with their
 EPA partners.
- Input from other programs on what is or is not working for them. Education on different areas of the grant. Increase knowledge/ability on items that are in the workplan.

DID THE VIRTUAL FORMAT WORK FOR YOU? ANY SUGGESTIONS TO MAKE IT BETTER IF WE HAVE TO DO ANOTHER VIRTUAL MEETING?

- Virtual was fine for me as I took the opportunity to pick and choose presentations of interest.
 However, I do not believe this is the intent as this is not a conference but a meeting. A virtual
 format in this manner, I would suspect there was a lot less than the desired attentive participant
 interactions. This may also have been a function of the topics as well. Recommend for future
 meetings, the agenda reflect each participating tribe who would provide a 30-45 min
 presentation of their local efforts, project, challenges, success story, or case study. The tribes
 should take center stage.
- I enjoy the virtual format.
- The virtual format worked very well. One suggestion would be a half hour before and half hour after of visiting/get to know each other sessions that are voluntary to attend but would be beneficial for everyone in an emotional/mental/social way.
